Lifetime Warranty on frame & sash

For as long as you own your Landmark window, Landmark warrants the frames and sashes of its Landmark window against separation, chipping, cracking, peeling, blistering, pitting and warping.

Lifetime Warranty on hardware & moving parts

For as long as you own your Landmark window, Landmark warrants the hardware and moving parts of its Landmark window or door against breakage, cracking or other failure.

Lifetime Warranty on screen & screen frame

For as long as you own your Landmark window, Landmark warrants the screens and screen frames of its Landmark window against chipping, cracking, peeling, blistering, pitting and warping.

Lifetime Warranty on labour

Your Landmark window is warranted for labor on repair or replacement of the window or any component part thereof, for as long as you own your Landmark window.

Lifetime Warranty on glass seal

For as long as you own your Landmark window, Landmark warrants the glass seal against failure, and material obstruction of vision caused by film, dirt or condensation between the interior of glass surfaces. This warranty does not cover condensation, frost, fog or obstruction of vision from film, dirt or other matter on the exterior surfaces of the glass (whether on the inside or outside of the building).

Lifetime Warranty on all Landmark Products

Landmark Window Systems warrants that all Landmark products installed, shall be free from defects in materials and workmanship, for the life of the product, or for as long as the original owner continues to be the registered owner of the premises in which they were installed.

This warranty is specific to extend warranty coverage against all failure of seals in insulated sealed glass units, and also warrants covering all latches and other hardware in the Landmark products.

Other Manufacturer's Warranties

Should a manufacturer's warranty exist on any of the Landmark products installed by Landmark Window Systems, this warranty will be in agreement with all the terms and conditions of that warranty, with the exception of the duration. The duration of this warranty shall remain as stated herein.
